3. TERM – The Government will commence delivery as soon as possible with an objective to be completed by September 30, 2021. Contractor shall return all exchange oil plus premium barrels to the West Hackberry SPR site during the months of January 2022 through February 2022. Contractor's oil return schedules must be approved by the Government prior to delivery. Also, see Provision 18 for additional scheduling requirements.

All other provisions of the agreement remain the same.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
