Furthermore the quality will be substituted, per clause B.9 of the contract, from Southern Green Canyon (SGC) + West Texas Intermediate (WTI) to Poseidon crude. The Poseidon crude will be sourced from ExxonMobil at the DOE St. James facility and will use the same quality documentation on file to meet contract requirements of COA and comprehensive assay. Per clause B.9 of the contract there will be a \$3,500 charge added to the close out reconciliation for this substitution.
