Description: Contractor shall provide all labor, tools, equipment, materials, consumables, services, transportation, storage and supervision necessary to perform the site building upgrades.

The work includes the following:

Building 301 Renovate men and womens restrooms - remove all water closets, urinals, lavatories and replace with new fixtures, remove and replace all flooring, remove and replace all wall tile and gypsum board, remove and replace all existing bathroom partitions, remove and replace restroom doors and door frames, remove and replace existing ceiling tiles and grid, demo plumbing chase wall and janitor's wall.

Building 302 – Repair or replace damaged exterior panels, roof panels and components. Furnish and install 3M Ultra 8mm S800 film, or approved equal, impact resistant film on interior face of existing glazing of all windows, doors and sidelites.

Building 308 – Remove large sliding doors and replace with electrically operated, insulated roll-up doors.

Building 310 – Remove existing roll up doors and replace with electrically operated insulated new roll up doors. Replace all splash block on building south side.

Building 313 – Prime and coat roof, vents, curbs, caps and all miscellaneous flashing with reflective coating system and reseal all roof penetrations.

Building 314 – Replace damaged exterior panels, roofs and components. Remove and replace existing interior damaged insulation on East Wall of the building.

Building 318 – Furnish and install 3M Ultra 8mm S800 film, or approved equal, impact resistant film on interior face of existing glazing of all windows, doors and sidelites. Demolish handicap parking spots, sidewalk and walkway. Install catch basins and tie the drains into the existing drain line. Install new concrete walkway.
