In accordance with DEAR 970.5232-4 - Obligation of Funds, the total funds obligated to this contract are increased by \$47,400,000.00 to provide \$34,900,000.00 for the Life Extension 2 (LE2) Program and \$12,500,000.00 for Facilities and Management. This will fund Facilities and Management to 43% of the Annual Operating Plan (AOP), to include all of March non-labor and 65% of April labor.

As a result of this modification, the total funds obligated to this contract are increased by \$47,400,000.00 from \$261,499,992.00 to \$308,899,992.00.

The current contract value remains unchanged at \$1,451,323,152.00.
